
INVITATION FOR

Expression of Interest (EOI) forDisposal of Various Sizes of Piping System



INTRODUCTION

Igeria LNG Limited (NLNG) production plant located on Bonny Island, Rivers State, Nigeria, consists of six (6) natural gas liquefaction trains with a total capacity of twenty-two (22) million tons of Liquefied Natural Gas (LNG) and five (5) million tons of Natural Gas Liquids (NGL) per annum. A seventh train is presently under construction. The production plant is operated by a dedicated team of operators, specialists and service providers who ensure continuous production round the clock.

NLNG hereby invites interested companies (including foundries and scrap metal buyers) with the requisite experience detailed below to express their interest to participate in a competitive bidding process for this material disposal.

SCOPE

Material to be disposed consist of various sizes (ranges from: 1/2" Pipe CS to 14" Pipe CS) of internally corroded above ground carbon steel fire and service water piping system. Material shall be disposed 'as is' and 'where is', and successful bidder shall be required to evacuate the materials from NLNG Plant Bonny location within a specified period.

Commencement and Duration

The expected date of the competitive bidding exercise is Q3 2024.

PRE-QUALIFICATION

Only companies considered to meet NLNG's pre-qualification requirements shall receive further correspondence from the Company, including receipt of invitations to bid for the Disposal of the various sizes of the piping system.

To qualify for consideration, interested companies are required to respond to this invitation with the following information/documents for consideration. Failure to submit any of the under-listed documents may lead to disqualification.

- a) Confirmation of interest to participate in the pre-qualification exercise for the Disposal of the various sizes of the piping system.
- b) Certificate of Incorporation and Corporate Affairs Commission documents (forms CO2 and CO7 or their replacements)
- c) Current/Valid NMDPRA certificates to Operate and Manage Recyclable Waste
- d) Current/ Valid permits with Rivers State Ministry of Environment (RSMEnv)
- Vendor's Health Safety & Environment Policy and Quality Management Policy
- f) Evidence of previous similar work experience (in managing recyclable waste/scrap buying) within the last 5 years
- g) Locations, addresses, and capacities of disposal facilities

- h) Financial audited accounts for the last three (3) years and evidence of capacity to fund the contract if successful.
- i) Evidence and documentation supporting compliance with the Nigerian Oil and Gas Industry Content Development (NOGICD) Act 2010 [See Nigerian Content Compliance section below]

General Nigerian Content Requirements

Companies responding to this advertisement are required to submit the following in compliance with the NOGICD Act, 2010 for the Expression of Interest.

a. Documentation to demonstrate that the entity is a Nigerian-registered company. Submission of certified true copies of CAC Forms 2A & 7A (or its equivalent) including company Memorandum and Article of Association. All companies shall be Nigerian Indigenous Service Companies having 51% and above Nigerian equity in the shareholding and ownership structure of tenderer's legally registered entity in Nigeria by CAMA (Companies and Allied Matters Act).

SUBMISSION OF RESPONSES

Submissions in response to the above requirements shall be completed strictly in accordance with the instructions given in this publication.

Failure to submit any of the documents may result in the disqualification of the applicant.
